

Support "An Act to Strengthen Impact, Efficiency and Accountability in the Government-Nonprofit Partnership"

SB 1486, LEAD SPONSORS: SEN, JENNIFER FLANAGAN & REP, LIZ MALIA

State government has become increasingly reliant on a partnership with the state's extensive nonprofit sector to address many of the Commonwealth's most important community needs and persistent challenges. Nonprofits are effective, efficient and essential partners in providing critical services, but their ability to continue to meet dramatically increasing demand is jeopardized by capacity and resource constraints.¹ Fortunately, innovative approaches are in development and in use in the Commonwealth, and across the country, which can dramatically improve the social and economic outcomes of this partnership. When these practices are identified and implemented across the entire government-nonprofit partnership, they will:

STRENGTHEN IMPACT ON IMPORTANT COMMUNITY NEEDS IMPROVE EFFICIENCY IN THE GOVERNMENT-NONPROFIT PARTNERSHIP ENHANCE ACCOUNTABILITY BETWEEN GOVERNMENT & NONPROFITS

Nonprofits educate and keep us healthy; they support our most vulnerable populations; and they care for our cultural, historical and environmental treasures. Nonprofits employ 16.7 percent of the workforce in Massachusetts and have nearly \$250 billion in annual revenuesⁱⁱ. There are over 4,767 grants and contracts between the state and nonprofit organizationsⁱⁱⁱ.

An Act to Strengthen Impact, Efficiency and Accountability in the Government-Nonprofit **Partnership** establishes a permanent Interagency Coordinating Group ("Coordinating Group") to work collaboratively to identify and implement practices that improve the impact, efficiency, and accountability across the government-nonprofit partnership and to report on how those practices have increased the state's ability to address important community needs and persistent challenges. The Coordinating Group will convene a Commission of leaders from the public, nonprofit and private sector to study, gather public input and make initial recommendations based on best practices and innovative approaches used in the Commonwealth and across the country.
