The Excellence Award for small nonprofits recognizes a nonprofit organization whose budget size is \$250,000 or less and that, despite their small size, has managed to fulfill their mission and make major contributions to the population they serve.

Please be as specific as possible when completing the nomination and be sure to highlight why the nominee is uniquely qualified for this award. Nominations will effectively convey the following criteria about how the organization:

- 1. Overcame challenges related to having a small budget in order to fulfill its missions
- 2. Created and implemented effective organizational strategies to increase capacity, strengthen programs and/or amass resources.
- 3. Utilized strategic or innovative methods to leverage resources and staff in order to make the greatest impact possible
- 4. Achieved meaningful and measureable outcomes with a strong plan for sustainability

Deadline: The deadline for all nominations is Tuesday, March 10, 2015.
