What must a company contribute?	<ul style="list-style-type: none"> <li>• Grant funds must be matched dollar-for-dollar</li> <li>• Match may include in-kind expenses such as employee wages during training</li> </ul>	<ul style="list-style-type: none"> <li>• Companies must contribute 50% of the total cost of training</li> </ul>	<ul style="list-style-type: none"> <li>• Companies must pay employees their full wages for time spent in training</li> </ul>	<ul style="list-style-type: none"> <li>• Grant funds must be matched dollar-for-dollar</li> <li>• Match may include in-kind expenses (e.g. staff time or other related costs).</li> </ul>
What can be paid for using grant funds?	<ul style="list-style-type: none"> <li>• Grant funds may be used to pay for employee training delivered by qualified training vendors of applicant's choosing.</li> <li>• In rare cases, grant funds may cover the cost of training delivered by company employees</li> </ul>	<ul style="list-style-type: none"> <li>• Grant funds will pay for up to 50% of the cost of training courses chosen from a database of pre-qualified courses</li> </ul>	<ul style="list-style-type: none"> <li>• A variety of courses are available; to download the complete course list, please visit the program website linked above</li> </ul>	<ul style="list-style-type: none"> <li>• Grant funds may be used for costs associated with planning for a General Program Training Grant (e.g. convening a group of employers with common training needs, customize training curricula, assessing training needs)</li> </ul>
Grant Limits	<ul style="list-style-type: none"> <li>• Up to \$250,000</li> </ul>	<ul style="list-style-type: none"> <li>• Businesses may receive up to \$30,000 each year; maximum \$3,000 per course per trainee</li> </ul>	<ul style="list-style-type: none"> <li>• This program provides access to training when the scope and scale of needs are not sufficient to warrant a General Program grant</li> <li>• Pre-approved training providers will work with companies to determine if restrictions apply</li> </ul>	<ul style="list-style-type: none"> <li>• Grants for technical assistance range from \$5,000 to \$10,000.</li> </ul>
