The Excellence Award in Collaboration recognizes the lead organization that was the catalyst for an effort by two or more nonprofit organizations that partnered to address a compelling problem that could not have been solved as effectively by the individual organization(s).

<u>Please be as specific as possible when completing the nomination and be sure to highlight</u> why the nominee is uniquely qualified for this award. Nominations will effectively convey the following criteria about how the organization(s):

- 1. Identified a clear and compelling need in the local community/nonprofit sector
- 2. Identified an approach, and appropriate partners, to respond to the need by working collaboratively
- 3. Worked with their partner(s) to meet the need by defining roles, effectively allocating combined resources, utilizing efficient communication, and implementing a clear process for accountability
- 4. Achieved meaningful and measureable outcomes that were made possible through collaborative efforts

**Deadline:** The deadline for all nominations is **Tuesday, March 18. 2016.**
