**Please be as specific as possible when completing the nomination and be sure to highlight why the nominee is uniquely qualified for this award. Nominations will effectively convey the following criteria about how the organization:**

1. Identified a compelling need or challenge that existed internally or in the local community
2. Created and implemented an innovative model, solution, or strategy to address the identified need
3. Used new and creative tools and approaches to successfully achieve goal(s) in ways different more conventional approaches
4. Achieved meaningful and measureable outcomes with a plan for continued sustainability of new model, solution or strategy

**Deadline:** The deadline for all nominations is **Tuesday, March 18, 2016.**
